Issues that we are facing and updates: I have sent a letter to all Branch Presidents and Secretaries to convene and also discuss the Minimum Wages Act and the raids that are happening concerning this in the branches and give representations to the District Collector and District Labour

office along with the Act, the subsequent formation of the committee and our representation given to the Government. We have sent all necessary copies to the branches and hope that it has been circulated amongst all members. Any specific instances, please bring it to the notice of the State Office and NHB Office, so as to follow it up in the State level. We have already given a representation that, no raids should happen by the Labour office till the present committee comes to a conclusion on the rates and wages.

We would like to thank the State Government for notifying that all drugs should be sold or supplied from the medical shops only with a prescription.

There have been notifications from NMC concerning NEXT which is the licentiate exam for practice and registration and also PG entrance exam. We have had discussions concerning this with the MSN and JDN, but having that as only the PG Entrance Exam would be better as the undergraduates undergoing MBBS can register with the Medical Council only on passing which might delay the process and the tremendous Mental and Physical strain they would have undergo after a rigorous Four and a half years of study along with the exams each year. A single day of MCQs cannot decide the knowledge of the students with entire curriculum starting from the first to fourth year as syllabus would be very strenuous and mentally taxing. We need to change this and show our opposition atleast. Conducting the PG Entrance Exam is ok but not as a licentiate exam for registering to practice.

We are proud and honored to congratulate our Imm. Past National President Dr.SAHAJANAND PRASAD SINGH on being nominated to the NMC Ethics and Medical Registration Board and our TNMC and TNGDA President Prof. Dr. K. SENTHIL Nomination as Member of theNMC Post Graduate Board.

We are sure that their service to the association and our fraternity will be even more on this added responsibility.

The Union Government has also formed a National commission for controlling medical inflation, which again will be fixing the charges for various procedures and surgeries in our hospital which again most probably is detrimental to our services.

We should raise our concerns regarding the rates for procedures from the National IMA and the Hospital Board of India chaired by Dr. A.K. Ravikumar who's already prepared the realistic costing study for a lot of Medical and Surgical procedures. We have submitted the same to the Insurance companies but yet to get a favorable reply.

The Insurance Schemes, Government and Private ones are giving us a pittance compared to the actual, we request the branch Presidents and Secretaries to convene, discuss and send your recommendations and suggestions to the State Office and also the NHB office for taking it up further.

GENERAL INSTRUCTIONS

Election of the all PPLSSS Office Bearers will be conducted online by the election commission of IMA TNSB. The office bearers shall be elected only from the members of PPLSSS. The tenure, shall be for a period of two years. Only PPLSSS members who are in the active role are eligible to vote. The election shall be by online voting. Election notification shall be given in TIMA News Letter with enough time frame.

All posts are for one term only except the post of District Co-ordinator which a member can contest for 3 terms.

- a) Past State Presidents cannot contest for any post including District Co-ordinator - but can attend meetings with full voting rights.
- b) Past PPLSSS Chairmen are not eligible to contest for any post in the same scheme.

ELIGIBILITY FOR THE POSTS

For the Post of CHAIRMAN

1. Life member of IMA for 10 years
2. PPLSSS member for 10 years
3. Attended MCM for three terms. Should have been attended minimum 12 Management Committee meetings
4. Not eligible for reelection to the same post
5. Past State Secretary / Past PPLSS Secretary fulfilling the above criteria eligible to contest.
6. Past State Presidents are not eligible to contest.
7. Past Chairmen of the PPLSS Scheme are not eligible to contest
8. Should remit a non-refundable deposit of Rs. 10,000/-
9. Certificate from the PPLSSS Office for eligibility should be obtained by candidate prior to the election.

For the Post of VICE CHAIRMAN

1. Life member of IMA for 10 years
2. PPLSS member for 10 years
3. Attended MCM for two terms. Should have been attended minimum 10 Management Committee Meetings
4. Should remit a non-refundable deposit of Rs. 5,000/-
5. Certificate from the PPLSSS Office for eligibility should be obtained by candidate prior to the election.

For the Post of HONY SECRETARY

1. Life member of IMA for 10 years
2. PPLSS member for 5 years
3. Attended MCM for two terms. Should have been attended a minimum 8 Management Committee Meetings
4. Should remit a non-refundable deposit of Rs. 5,000/-
5. Certificate from the PPLSSS Office for eligibility should be obtained by candidate prior to the election.

For the JOINT SECRETARY / LEGAL COMMITTEE CHAIRMAN/ INTERNAL AUDIT COMMITTEE CHAIRMAN

1. Life member of IMA for 10 years

2. PPLSS member for 5 years





- Hospitals exiting from NHB Membership





The following are the major resolutions passed in the 72, 73 & 74th Management Committee Meeting of FSS of IMA TNSB.

(1) The first / original promise made in FSS at the time of inception for fixing the paying term is reinstated with little modification.

In FSS-1 and FSS-2 the paying term is restricted to 25 years for both new and existing members.

The previous amendment of life time payment is revised to 25 consecutive years of payment/contribution as per the popular demand of our members. After 25 years of payment they will continue in the scheme as honorary member and on the death of a member he/ she shall get the claim amount as per the effective membership strength in the scheme:

In FSS-1:Rs.200×effective members.

In FSS-2: Rs.300×effective members

• Solicit you all to work unitedly in oneness and add more members to our scheme and support each other families.

(2) The upper age limit to join in FSS 1 & 2 has been increased to 55 years from 50 years & the Non-refundable Deposit for 51 to 55 years category is fixed as Rs.55,000.

(3) It's decided to allow Defaulters/Deleted members to re-join in both our schemes for a limited period of time till 30th June 2023 with the following preconditions
